**Romcarbon Group** recorded in H1 2020 a net loss of LEI (1,642) thousand increased by LEI (478) thousand as compared with the same period of 2019 (H1 2019: LEI (1,164) thousand), and a value of net sales of LEI 126,910 thousand increased by LEI 5,116 thousand (+4.20%) as compared with the same period of 2019.

**EBITDA Operational** recorded in the reported period **an amount of LEI 8,367 thousand with an increase of LEI 4,040 thousand (+93%)** as compared with the same period of 2019 as a result of the investments made in the previous years targeting the increase of productivity and the decrease of production costs.

Among the items that negatively impacted the result of 2020 were the "Profit/loss from associates" LEI (2,308) thousand in H1 2020 compared with LEI 831 thousand in H1 2019 and "Other gains and losses" LEI (641) thousand in H1 2020 while in 2019 was recorded an amount of LEI 1,148 thousand.

## **About the Group**

Romcarbon Group consists of companies that produce: (i) plastic packaging products and other plastic profiles (Romcarbon SA and Livingjumbo Industry SA), (ii) regenerated polymers and compounds (Romcarbon SA), (iii) other productive activities (Romcarbon SA) and (iv) other activities such: plumbing, heating and air conditioning services and works (RC Energo Install SRL), business and business consulting services (Recyplat LTD), information technology services (InfoTech Solutions SRL) and others.

The major companies of the Group with production activities are Romcarbon SA and Livingjumbo Industry SA, owning 73% and 15% of total fixed assets.

The revenue distribution by field of activity in H1 2020 was as follows:

- plastics processing (polyethylene, polystyrene, polypropylene, PET, PVC): 82% (77% in 2019);
- recycling of plastic products: 9% (14% in 2019);
- other productive activities (production of filters for motor vehicles and industrial filters, production of respiratory protection masks, PVC traffic base): 2% (2% in 2019);
- other activities: 7% (7% in 2019).
