ROMCARBON S.A. reports that on 12.10.2020, concluded, at the agreed deadline, with OFFICE & LOGISTIC S.R.L. (Romanian legal entity, identified with J22 / 13/2018, CUI 38653333) the Sale contract having as object the sale of real estate owned by ROMCARBON S.A. located in Iasi, Calea Chisinaului no.29, Iasi county, consisting of land, with a total area of 2487 sqm. and of all the constructions located on this land, together with the special constructions (electrical cable networks) and with the movable property located on these plots, for the total price of 250.000 Euro, without VAT, in RON equivalent at the NBR RON/EURO exchange rate from the date of payment and the Contract for establishing an easement right for existing utility networks. The transfer of ownership over the assets mentioned above was made on 12.10.2020, the date of authentication of the sale contract in compliance with the following main conditions:

- Payment of the advance from the sale price, in the amount of 50,000 Euro, without VAT, in lei equivalent was paid on the date of signing the sale and purchase pre-contract (subject of Current Report no.1651/16.04.2020);

- The rest of the price, in the amount of 200,000 Euros, without VAT, in RON equivalent, was paid on the date of signing the sale contract, simultaneously with the transfer of the property right;
