Description of proposed investments

> PROFIT CENTER No. 3

✓ Homogenizing units 1 cm – 2 pcs

✓ Estimated value: 12.000 euro

In order to optimize the extrusion process, it is necessary to provide a homogeneous raw material that provides continuity to the technological process and ensures the same physic-chemical characteristics of the obtained products. Homogenizers are proposed for serving extruders which are not provided with multiple gravimeter dozing units, at present, homogenization doing by a device that rotate 2 tanks. The proposed new homogenizers have a capacity of 1 m3, and at a bulk density of ~ 0.6 t/m3, 600 kg/batch of raw materials can be homogenized.

Homogeneity of mixtures reduces:

- a) balloon instability during extrusion (especially at LD + HD, LD + LLD, LD + rPE)
- b) breaking of the balloon
- c) wider field for tolerances for physical-mechanical characteristics (traction, welding, etc.), optical, dimensional.

PROFIT CENTER No. 5

✓ Stretch wrap machine

✓ Estimated values: 4.950 euro

The investment is suitable for palletizing of EPS panels by implementation of it aiming at reduction of manpower from 4 people to 1 people and thus reduction of cost with this activity.

> PROFIT CENTER No. 7

✓ <u>Electrostatical separation</u>

✓ Estimated value: 400.000 euro

The proposed electrostatic separation line contains electrostatic separation units with advantages in terms of:

- separating of 2 polymers in one pass
- increased capacity comparative with the existing one
- lower operating costs (increased capacity)
- quality increase due to the successive separation in 3 steps
- using the optical separation line in parallel with electrostatic sorting
- reducing the existing stock of non-compliant product in a short time.

✓ Vacuum cleaner for dust and granules (2 pcs)

✓ Estimated value: 8.000 euro

As a result of the recycling/compaction activity dust emissions are absorbed by the filtration and ventilation systems, but a part of the dust maintained by moving machines is dispersed and can cause equipment malfunctions, alarm sensors, and last but not least, electrostatic charges and fire hazards. The industrial vacuum cleaner can provide cleaning for all surfaces affected by dust, a reduction in particle pollution. For dust extraction on machines and large deposition areas an ATEX vacuum cleaner is proposed to eliminate the risk of explosion.

For aspiration of contaminants in the enclosure, as well as for rapid emptying of the granule / grinding content of the homogenizers, an aspirator with a suction hopper is proposed.

✓ Roof for emptying stations of homogenizing units and project for it

✓ Estimated value: 31.000 euros

The investment consisting in a cover (including foundations and frame support) is intended to protect against environmental factors(rain, snow, UV radiation) the 3 discharge big bags which feeds the 50mc homogenizers. The rain water is accumulated in the pipes being difficult to transport and homogenize the wet fractions.

✓ Shredder for bones and others

✓ Estimated value: 29.809 euro

The shredder is intended for the crushing of bones resulting in both internal and external production processes, as well as the crushing of the hangers. The investment is recovered in ~ 1 year in the conditions of the realization of 2 new products (PP and EP) based on this raw material, at a capacity correlated with the production of bones.

MECHANICAL PROCESSING WORKSHOP

✓ Metallization machine

✓ Estimated value: 3.700 euro

Necessary for the reconditioning of the shafts, flat surfaces, this installation cover with a layer with few microns up to 2 mm of metal powders at very high temperatures. In this way it is no longer necessary to execute new replacement pieces with stressful wear.

All others positions including in Investment Plan at Administrative represents acquisition of IT goods and infrastructure works necessary for the operational activity of the company.
