We also want to inform the shareholders that, by applying the restriction measures in force on the Romanian territory, the company will have the legal possibility to limit the number of participants at the OGMS/EGMS meeting, to the maximum number allowed by the special provisions in force, on the date of the meetings.

Last but not least, we want to draw the attention of all the shareholders of the company to the fact that the trips for attending the OGMS/EGMS meetings as well as the participation in public events/meetings held in closed spaces such as the OGMS/EGMS meetings, create the premises of the participants' exposure to a possible contamination with COVID-19, in spite of all sanitary hygiene measures respected by both participants and society.

Depending on the evolution of the situation regarding the COVID-19 epidemic as well as the measures imposed by the authorities at the date of the OGMS/EGMS meetings, the company will make every effort to ensure the participants comply with the protection norms. Thus, upon entering the premises, the shareholders will complete a declaration on their own responsibility and the temperature will be taken, and will be distributed, as the case may be, protective materials, to those who do not have such means of protection, also having the possibility of disinfection.
