We kindly ask you to submit for approving in EGSA the following:

- > The possibility to contract if it is needed a factoring facility with the ceiling of EUR 500,000 for a period of 36 months;
- the extension at maturity or, if necessary, before the maturity of the bank letter ceiling contracted with UniCredit Bank SA in the amount of RON 500,000 with a period of 36 months and / or the modification of the guarantees with the establishment of a real movable mortgage on 4 machines having a market value according to the valuation from 06.01.2022 of EUR 270,900 and a net book value on 28.02.2022 of RON 732,054;
- > 12 months extension of the credit line contracted with Exim Bank SA (amounting to EUR 2,550,000) and with UniCredit Bank SA (amounting to EUR 5,450,000) maintaining the afferent guarantees;
- > Contracting a multicurrency credit for investment, for financing the investment plan for 2022, in amount of EUR 2,965,000 for a period of 60 months;
