Plasticul este folosit in aproape toate produsele ce ne inconjoara. Acesta este un produs care are nenumarate posibilitati de utilizare in acest moment, incepand cu utilizarea lui in constructii (placi de pardoseala, saci de PE/PP pentru ambalare si transport materiale de constructii), in agricultura (folii pentru solare, saci PE/ PP), in industria alimentara ca ambalaj (casserole PSE, pungi PE, saci PE/PP) si terminand cu diverse (suporti PVC).

O caracteristica importanta a produselor de plastic este posibilitatea de a se putea recicla in foarte multe stadii ale sale ceea ce realizam in acest moment in sectorul nostru de reciclare, dotat cu echipamente performante .

Constientizand importanta ocrotirii mediului inconjurator, in sensul reducerii impactului negativ asupra acestuia, intregul colectiv al organizatiei isi desfasoara activitatea conform urmatoarelor principii:

- Precautiei, prevenirii, corectarii poluarii la sursa si "poluatorul plateste" care au la baza strategia de dezvoltarea durabila a Uniunii Europene
- Controlul si responsabilitatea la nivelul intregii organizatii, de la managementul de varf pana la salariatii

Conform acestor principii ne angajam:

- Sa ne conformam legislatiei de mediu si a altor cerinte aplicabile la care ROMCARBON a scris si sa optam pentru prevenirea poluarii si promovarea unui mediu inconjurator sanatos
- Sa ne implicam in protectia mediului prin:

  - reducerea utilizarii substantelor toxice si periculoase

  - instruirea personalului in vederea desfasurarii unei activitati responsabile fata de mediul inconjurator;

Plastic is used in almost all products around us. This is a product that has many possibilities for use at the moment, starting with its use in construction (floor tiles, PE / PP bags for packaging and transport of construction materials), in agriculture (solar foils, PE / PP bags ), in the food industry as packaging (PSE casseroles, PE bags, PE / PP bags) and ending with various (PVC supports).

An important feature of plastic products is the possibility of recycling in many of its stages - which is what we are doing at the moment in our recycling sector, equipped with high-performance equipment.

With the awareness of the importance of protecting the environment and in order to reduce the negative impact on the environment, the entire company team operates according to the following principles:

- Caution, prevention, correction at the source of pollution and a "polluter pays" kind of policy which are based on the strategy of sustainable development of the European Union
- Control and responsibility at the level of the entire organization, from top management to employees

According to these principles we are committed to:

- Comply with the environmental legislation and other applicable requirements to which ROMCARBON has subscribed and to choose to prevent pollution and promote a healthy environment
- Get involved in environmental protection by:
  - the efficient use of raw materials and material and energy resources;
  - reducing the effects on the environment (emissions, emissions, waste) by keeping processes under control
  - reducing the use of toxic and dangerous substances
  - selective collection and recovery in conditions of maximum safety of residual waste;
  - training the staff in order to carry out a responsible activity towards the environment;

- Collaborate with authorities and stakeholders to report and resolve any environmental issues and implement a sound environmental policy


The environmental policy is regularly updated to ensure the continuous adaptation of the company's needs and stakeholders and is available on the company website.
